



# Lake County Winegrower Vineyard Signage Program

## Vineyard Signage Order Form

The Lake County Winegrape Commission has created the Lake County Winegrower Vineyard Signage Program to support Lake County winegrowers in branding their vineyards and to convey a professional image of the Lake County winegrowing region. The new sign design features a main regional panel; a custom panel that highlights the vineyard name/brand, AVA, and vineyard elevation; and an optional panel that highlights key varieties grown at that vineyard location.

The Lake County Winegrape Commission has funded the overall sign design work, so winegrowers only pay for production costs for their sign(s).



The sign is two-sided to be visible from both directions of traffic. Signs should be set back from the road and out of the county right-of-way. For any questions regarding placement on your property, please contact the Lake County Community Development Department at (707) 263-2221.
